About Us

Richmond Landcare Incorporated (RLI) is a not-for-profit, community-led Landcare network formed in 1998 to support Landcare in the Richmond River catchment on the Far North Coast of NSW.

RLI recognises we live in a catchment that is unique in its First Nations cultural values and biodiversity and strives to support and enhance these valuable attributes within our catchment. To do this RLI provides support to new and established Landcare groups and is building effective working partnerships with other groups within the Bundjalung community that have a similar objective. We also support best practice by private landholders for managing land and water across all landscapes.

RLI is a participating member of both the regional Landcare body, North Coast Regional Landcare Network and the state group, Landcare NSW.

Our Governance

The RLI leadership team is made up of a committee of volunteers drawn from representatives of its member groups. This committee guides the strategic direction and governance of Richmond Landcare Inc. In 2022–2023 it met six times. During the 2022– 2023 financial year the committee continues to review its governance, in particular policies and procedures relating to employee and committee welfare and to employment conditions.

The Committee

Chair - Shaun Eastment



Shaun represents Lennox Head Landcare, joining them in 2009. Prior to that she had a career in education for 32 years with a variety of leadership roles in schools. At the same time, she was actively involved across the Sydney Metropolitan area in professional support for teacher education and across the state in programs to develop student participation in the sciences. Shaun is passionate about building community and a sense of the value of our natural environment. She has a bush garden and, through Lennox Head Landcare, is working with community members to enhance our natural areas and to encourage our broader community and our local council to value and protect those areas in the face of increasing population and commercialism.

Secretary - Dr Hedy Bryant



Since moving to the Northern Rivers in 2019, Hedy has been volunteering on the dunes with Ballina Coastcare. She is currently the Secretary of Richmond Landcare Inc. Being connected to grassroots action and the natural environment is central to her sense of purpose and place. Hedy is semi-retired and keeps her hand in lecturing in contemporary leadership and contributing to research into curriculum development and disaster resilience. She has a diverse background with formative experiences working in natural resource management, vertebrate pest management, exotic disease preparedness, catchment management and Landcare in the 1980s and 1990s; coordinating the establishment of the Australian Wildlife Health Network in 2002. Her favourite plant is the grevillea because of its attraction to birds, while on the dunes it's the coastal banksia - *Banksia integrifolia*.

Treasurer - Lyn Thomson



Back in 2009 Lyn was Richmond Landcare's part-time School's Officer, working on various environmental projects with many schools in the Richmond Catchment. She also worked part-time for The Australian Native Bee Company, educating schools and the community on the importance of Australian Native Bees. Now in retirement, Lyn is currently Treasurer of Richmond Landcare representing Bagot Park Landcare, an Executive member of North Coast Regional Landcare and a Director and Secretary of Landcare NSW. Some of her passions are, her grandchildren, Australian Native Bees, gardening and working with Steve, her husband, restoring their 110-acres (44 hectare) property at Swan Bay. Their farm was previously a sugarcane farm; slowly the swamps are rejuvenating, and they are now planting thousands of trees on the farm. She happily reports that the birds and 'the bees' are returning. When asked about her favourite hat and plant, she replied, "I rotate my favourite caps between my RLI cap, my NCRLN cap, and of course my bee veil hat. My favourite plant is the Blue Tongue, Melastoma affine, a favourite of Blue Banded Bees."

Committee Member – Big Rob

Liss serves Lismore Council as a committee member on the Disability Inclusion Advisory Group.



Our Projects

During 2022-2023, our staff successfully delivered fourteen projects worth a total of over \$157,000.

These projects covered a range of themes from support for Landcare groups, threatened and endangered species protection, weed control, riparian restoration, community engagement, delivering property assessments for Land for Wildlife status and support for landslip assessments, management and maintenance following the disastrous flood events of February and March 2022.

Membership

Membership of RLI is open to any Landcare-type group in the Richmond River catchment subject to approval by the management committee. Our membership support program is currently under review and we are in the process of developing a stronger Landcare community among our member groups as well as improved access to training and educational opportunities.

Currently we have over 100 member groups.

NSW Landcare Program (NSWLP)

This Program is a collaborative endeavour of Local Land Services (LLS) and Landcare NSW Inc. (LNSW), supported by the NSW Government. It recognises the value of government and Landcare working together and aims to support and enable partnership outcomes for both Landcarers and Local Land Services. The Program's purpose is to play a role in empowering local Landcare volunteers by contributing to the systems, partnerships and structures that underpin their capacity to achieve outcomes.

Under this program RLI has a contract with North Coast Regional Landcare Network (NCRLN) to employ a Local Landcare Coordinator. The role of the coordinator in the 2019-2023 program has been that of an enabler for local community Landcare. Local Coordinators work with their host organisation and the Landcare groups and organisations of their area to support and empower them to achieve their own goals. Additionally, Coordinators facilitate awareness of the Landcare program in the broader community, support the development and delivery of projects to repair and enhance the local environment and develop partnerships with other local and government organisations to further these goals. The NSWLP is currently under review prior to launching the 2023-2027 program.

Relationships and Partnerships

We have built relationships and partnerships with local organisations that support Landcare including:

- Traditional Custodians of the Bundjalung Nation for project delivery including Jagun Alliance Aboriginal Corporation, Ngulingah Local Aboriginal Land Council, Jali Land Council, Jargoon Heritage Consulting and Gilbert Laurie and the Bundjalung Tribal Society.
- Richmond River Collaborative Partnership includes approximately 50 stakeholders discussing projects that impact the health of the creeks and rivers of the Richmond River catchment.
- A Memorandum of Understanding with Lismore City Council that helps us support Landcare groups and the broader Natural Resource Management.
- A draft Memorandum of Understanding with the Bundjalung Tribal Society to be endorsed in mid 2023.
- An agreement with the Community Environment Network to carry out Land for Wildlife assessments.
- New partnerships with World Wildlife Fund Australia and Northern Rivers Community Foundation.
- Ongoing working relationships with a wide range of organisations and networks, including Northern Rivers Science Hub, Northern Rivers Group of Environmental Educators, Ballina Shire Council, Ballina Shire Coastal Advisory team, North Coast Local Land Services and Rous County Council.
- Collaboration with neighbouring Local Landcare Networks and the North Coast Regional Landcare Network on funded and non-funded projects.
- Engagement with local political representatives to gain support for the new Landcare Program.

Our Key Achievements

- Implementation of our Reflect Reconciliation Action Plan (RAP).
- New website developed and published.
- Successful grant application for Nature-Based Solutions: Building Flood Resilience in the Lismore Catchment through the Australian Government Disaster Ready Fund, round 1.
- Continuation of a networking and training support program for member groups.
- Continuing support for our community in flood recovery through sourcing of ongoing funding for landslide remediation.
- Provision of land management advice to private landholders and farmers.
- Initiation of a cooperative working relationship with Jagun Alliance and the Bundjalung Tribal Society.
- Consolidation of our systems and procedures to streamline the organisation.
- Expansion of our externally funded project program.
- Collaboration with Lismore City Council, Rous County Council and Inspiring Australia on funded and partner projects.
- Delivered and contributed to events and field days to engage and educate members of our community including:

- Continue to facilitate and advocate for individuals, groups, and the wider community for Landcare.
- Continue to provide education opportunities on best-practice for land and water management.
- Continue to embed a Landcare ethos of caring for land and water within our community
- Further develop our engagement with the Bundjalung community in caring for land and water.
- Develop a communication strategy.
- Achieve Deductible Gift Recipient (DGR) status.
- Continue to advocate for and provide support to local landholders experiencing landslips.
- Investigate ways to support local landholder participation in the emerging environmental services voluntary market.
- Continue to strengthen our governance.
- Consolidate our existing partnerships whilst identifying opportunities to expand our range of partnerships with local government, local businesses, organisations and community groups.
- Expand and maintain an effective program providing networking opportunities and training for our member groups.
